Audit Committee

In accordance with Section 404(6) of the Companies and Allied Matters Act, 2020 any shareholder may nominate another shareholder as a member of the Audit Committee by giving notice in writing of such nomination to the Company Secretary at least 21 days before the Annual General Meeting.

Section 404(5) of Companies and Allied Matters Act, 2020, provides that all the members of the Audit Committee shall be financially literate and at least one (1) member shall be a member of a professional accounting body in Nigeria established by an Act of the National Assembly. The Code of Corporate Governance issued by the Financial Reporting Council of Nigeria also provides that members of the Audit Committee should be financially literate and able to read and interpret financial statements. In view of the above, nominations to the Statutory Audit Committee should be supported by a Curriculum Vitae of the nominees. We therefore request that nominations be accompanied by a copy of the nominee's curriculum vitae.

Right of Shareholders To Ask Questions

Pursuant to Rule 19.12 (c) of the Nigerian Stock Exchange's Rulebook 2015, please note that every shareholder has a right to ask questions not only at the meeting but also in writing prior to the meeting, and such questions must be submitted to the Company not later than two weeks before the date of the meeting.
